PROGRAM OF JUDGING

Dogs may arrive any time prior to scheduled time of judging. Dogs not required for further judging may be excused. Judges are not required to wait for any dog. They will adhere as closely as possible to the judging schedule. Judges may take breaks at their discretion. The owner or handler of each dog is solely responsible for having it ready at ringside when it is to be judged. All dogs present must be held on leash or be confined to their crates except when being judged. No practicing allowed in rings at any time.

DIRECTIONS TO KIRIGIN CELLARS WINERY – Take Highway 101 north or south to Morgan Hill. Take the Tennant Avenue exit. (If coming from the north, turn right onto Tennant Ave.; if coming from the south, turn left onto Tennant Ave.) Turn left on Monterey Rd./Monterey Hwy. Turn right on Watsonville Road for 4.8 miles. Kirigin Cellars is on the left.

Follow signs/directions for parking. **DO NOT** park next to any buildings; this area is reserved for winery guests ONLY.
