All dogs present must be held on leash or be confined to their crates except when being judged. No practicing allowed in rings at any time.

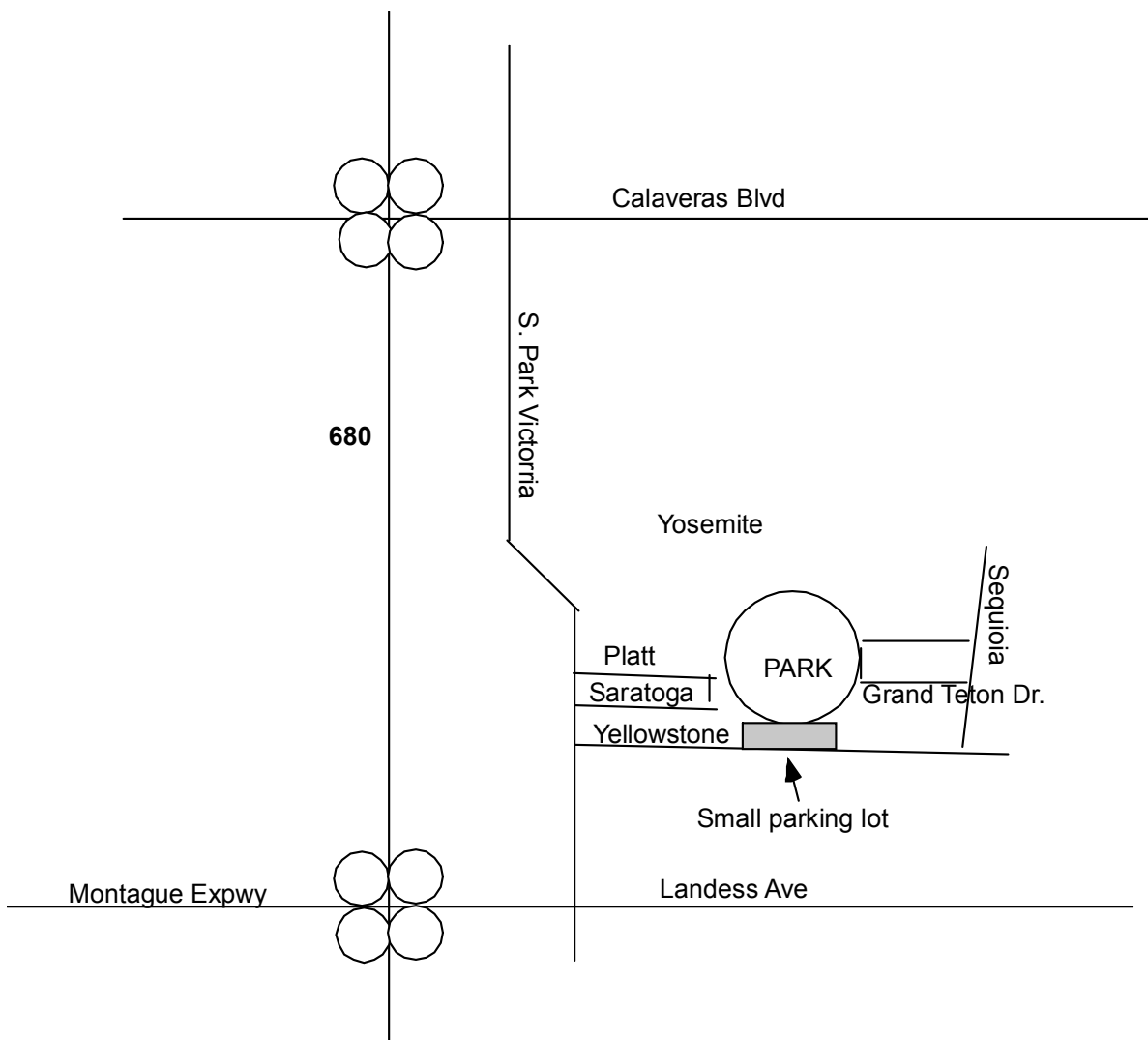

DIRECTIONS TO MURPHY PARK – Take Highway 680 north or south to Milpitas. Exit Landess - East. Turn Left on S. Park Victoria Dr. Go about 0.5 miles, turn Right on Yellowstone Ave. See Map for additional parking on side streets.

VETERINARIAN (on call) – Olhone Emergency Veterinary Hospital, 1818 Washington Blvd, Fremont. Take 680 North to Washington Blvd. Proceed straight at signal and turn left behind buildings to parking lot.

There is limited parking in the parking lot but there is plenty of street parking. You can park on either side of the park. If you are coming from Landess, go past Yellowstone, one block and turn right on Saratoga; go to the end of the street and you can park alongside the Park. Or, you can turn right on Yellowstone and go past the Park to Sequoia. Turn left on Sequoia and then turn left on Grand Teton Dr. and go to the end and follow right to park on the curb.
